Application period **July 8, 2019 to October 8, 2019**

What you need to know before applying

Who can apply?

1. Status in Canada

Do you have:

- Valid Work Permit
- applied to or eligible to apply to extend work permit and waiting for decision
- applied to or eligible to apply to restore status as worker

You are not eligible in the interim pathway, if:

- refused work permit extension
- refused restoration application
- current work permit is in the Live-in Caregiver Program (LMIA approved before November 2014)

Others:

2. Work experience

You need to have worked in Canada for at least **12 months** of service on a caregiver work permit since **Nov. 30, 2014**

Worked as:

- home child care provider (NOC 4411)
- home support worker (NOC 4412)
- combination of the two

- at least 12 months of full time work since Nov. 30, 2014
 - at least 30 hrs/week
- proof of service: (at least one)
 - Copy of work permit
 - Copies of your T4 tax information slips
 - ROE
 - Employer reference letters
 - Period of employment
 - Description of main responsibilities and duties
 - NOC code
 - Total annual salary and benefits
 - Number of hours worked per week (must be at least 30 hrs/wk)
 - Employer's name and signature, full address, telephone number, email address
 - Notice of assessment (CRA)

You are not eligible in the interim pathway, if you have:

- less than 12 months of full time work
- work permit under the Live-in Caregiver program

Others: (write other issues not mentioned above, example: problem getting ROE)

3. Language level

You need to take an approved language test and get **CLB level 5**.

IELTS fee: \$319 (results: 2-3wks) , CELPIP: \$280 (results: 8 business days, view online)

Have you taken the language test?

If YES, you need to submit:

- Original test result with at least CLB 5 in all four language skills
 - **CELP-IP-G score:** CLB level 5 in all 4 skills (writing 5, reading 5, listening 5, and speaking 5), or
 - **IELTS General Training score:** CLB level 5 (writing 5, reading 4, listening 5, and speaking 5).

NOTE: Test must have been done within the past two years

If NO, you need to submit:

- Proof that you scheduled your test with an approved agency
 - Include the date that you'll be taking your test
- Proof of test payment

NOTE: Once you get the original test results, the date on your test results must match the date you gave on your application.

You are not eligible in the interim pathway, if you have:

- negative result of the test
- one of the language skills is below CLB 5 (except for IELTS reading skill, you need at least a score of 4)

Didn't get CLB 5?

For IELTS, you can apply for Enquiry on Results (EOR), to review your final score within 6 weeks of the test date. Check their website to find out how to apply: <https://www.ieltscanada.ca/resultsenquiry>

For CELPIP, you can apply for re-evaluation within 6 weeks of the test date.

Others:

4. Education

You need a **Canadian high school diploma or higher**, you must get an **Educational Credential Assessment (ECA)** from an approved organization.

Which of these organizations did you get assessed?

- Comparative education service (University of Toronto School of Continuing Studies)
- International Credential Assessment Service of Canada (ICAS)
- World Education Services (WES)
- International Qualifications Assessment Service (IQAS)
- International Credential Evaluation Service (ICES)

What to include in your application?

- original ECA report, showing credentials are equal to a completed **Canadian high school diploma or higher**
 - Your assessment must be within the last 5 years when you apply
- copies of your degrees, diplomas, transcripts or other proof of your completed foreign credentials

If you don't have the ECA report yet, you can submit:

- Proof that you have applied for an ECA includes **written confirmation from the agency** that you have submitted a request for an ECA
- Receipt of payment

You are not eligible in the interim pathway, if you have:

- ECA report is below Canadian high school diploma

Others:

5. Biometrics

If you are currently inside Canada, you are exempt from the biometric requirement. But your family members may need to appear in person to have their fingerprints and photograph (biometric information) taken at a biometric collection service point. Check IRCC website to check the nearest official location in each country.

6. Medical exam

You do not undergo an immigration medical exam unless IRCC advise you to do so. A medical exam will be required but you will have to wait for the response from IRCC. They will send you instructions after submitting your application.

7. Police Certificate

If you have spent six or more months in another country You and your family members who are 18 years of age and older must provide a valid police certificate for each country other than Canada, in which you have spent six or more months since the age of 18.
